## *East Link construction impacts to Bellevue City Hall*

Accessing Bellevue City Hall during East Link construction may be challenging in the coming years, and we ask for your patience. The area around City Hall is an active construction zone. Please be safe and follow all flaggers' instructions and construction signs.

Visitor parking at City Hall will be prioritized for customers who are conducting business with the city or attending some city meetings including City Council meetings, public hearings, advisory boards and commission meetings.

Free evening parking for the public will be available after 4:30 p.m. in the East Employee Garage (P2 level), which can be accessed from 112th Avenue NE between NE 6th Street and NE 4th Street. The city's parking management services will be enhanced to assist daytime visitors.

City staff are committed to providing you exceptional customer service. Plan your next trip to City Hall by allowing extra time to complete your business with us. We look forward to serving you.

Starting in June 2017 and continuing for a few years, Sound Transit's construction to build East Link light rail will impact how you access Bellevue City Hall. The Bellevue Downtown Station is being built at the northern portion of the plaza area and will be connected to the tunnel that is being excavated along 110th Avenue NE. This construction is expected to be complete in late 2020.

Construction impacts near and on the City Hall campus include:

- Less visitor parking available during and after construction
- Permanent closure of the NE 6th Street access
- Construction work zone at the vacant lot adjacent to City Hall
- Construction of a mid-block pedestrian crossing at 110th Avenue NE
- Extended full closure of a portion of 110th Avenue NE near NE 6th Street
- Lane closures on NE 6th Street to build the station and elevated guideway over 112th Ave NE and I-405
